

This cookie policy was last updated on March 5, 2024 and applies to citizens and permanent legal residents of the European Economic Area and Switzerland.

1. INTRODUCTION

Our website, <https://salaet.com/es/> (hereinafter: “the Website”) uses cookies and other related technologies (for convenience, all technologies are referred to as “cookies”). Cookies are also placed by third parties with whom we have contracted. In the following document we inform you about the use of cookies on our website.

2. WHAT ARE COOKIES?

A cookie is a small file that is sent along with the pages of this website and stored by your browser on the hard drive of your computer or other device. The stored information may be returned to our servers or to appropriate third party servers during a subsequent visit.

3. WHAT ARE SCRIPTS?

A script is a piece of program code that is used to make our website work correctly and interactively. This code runs on our server or on your device.

4. COOKIES

· 4.1 Technical or functional cookies

Some cookies ensure that certain parts of the website work properly and that your user preferences are remembered. By placing functional cookies, we make it easier for you to visit our website. In this way, you do not need to repeatedly enter the same information when you visit our website and, for example, items remain in your shopping cart until you have paid. We may place these cookies without your consent.

· 4.2 Statistical cookies

We use statistical cookies to optimize the website experience for our users. With these statistics cookies we obtain information about the use of our website. We ask your permission to place statistical cookies.

· 4.3 Marketing/Tracking Cookies

Marketing/tracking cookies are cookies, or any other form of local storage, used to create user profiles to display advertising or to track the user on this website or on various websites for similar marketing purposes.

· 4.4 Social Networks

We have embedded Instagram content on our website to promote web pages (e.g., “Like”, “Pin”) or share (e.g., “tweet”) on social networks such as Instagram. This content is embedded with code derived from Instagram and stores cookies. This content may process certain information for personalized advertisements.

6. CONSENT

6.1 Manage your consent settings

- **Functional** (Always active)

Storage or technical access is strictly necessary for the legitimate purpose of enabling the use of a specific service explicitly requested by the subscriber or user, or for the sole purpose of carrying out the transmission of a communication over an electronic communications network.

- **Preferences**

Technical storage or access is necessary for the legitimate purpose of storing preferences not requested by the subscriber or user.

- **Statistics**

Technical storage or access that is used exclusively for statistical purposes.

- **Marketing**

- Right of rectification: You have the right to complete, rectify, delete or block your personal data whenever you wish.
- If you give us your consent to process your data, you have the right to revoke such consent and to have your personal data deleted.
- Right to transfer your data: you have the right to request all your personal data from the data controller and to transfer it in full to another data controller.
- Right to object: you can object to the processing of your data. We comply with this, unless there are justified grounds for the processing.
